## AGREEMENT FOR WEDDING SERVICES

1. This constitutes a contract and order for wedding consulting, flowers, catering, photographs, albums, prints or other services as mentioned or listed below. It is understood that arrangements will be made by our through An Affair to Remember, J Byous Photography on behalf of the bride or her representative, and that there will be a fee charges for making those arrangements of 15% with a \$850.00 minimum. The fee will be a percentage of the total price of goods and services for all arrangements made by An Affair to Remember, J Byous Photography. This percentage has been predetermined by An Affair to Remember, J Byous Photography and the bride or her representatives as written in this contract. It is understood that any and all preview prints, sample prints and negatives remain under the copyright of An Affair to Remember, J Byous Photography or James Byous and may be used for advertising, display, for use in editorial publications or any purpose thought proper by An Affair to Remember, J Byous Photography or James Byous unless agreed to by prior arrangement. It is agreed herein that photographs will not be copied, scanned or reproduced for any commercial purposes without the express permission of An Affair to Remember, J Byous Photography or James Byous. Sales tax applies to total when applicable.
2. An Affair to Remember, J Byous Photography will deal with all vendors, and will arrange for deposits to be made by the bride and/or her representative. An Affair to Remember, J Byous Photography will maintain copies of receipts for deposit and vendor contracts and will provide copies of each to the bride for non-photographic services. Although all care will be taken with the negatives and photographs taken at the wedding, An Affair to Remember, J Byous Photography limits any liability for loss, damage or failure to deliver pictures for any reason to return of all deposits made.
3. Should any vendor fail to perform as contracted, An Affair to Remember, J Byous Photography shall attempt to retrieve deposits and make alternative arrangements as time constraints permit, but shall not be held responsible for held responsible for said deposits.
4. Upon signature, An Affair to Remember, J Byous Photography reserves the time and date agreed upon and will not allow other reservations for that time and date to interfere with the completion of this contract. For this reason, all deposits made to An Affair to Remember, J Byous Photography are nonrefundable, even if date is changed or wedding canceled for any reason. Deposits made to vendors will be subject to rules and regulations stated in vendor contracts.
5. An Affair to Remember, J Byous Photography agrees to have a representative on site for the event to manage all aspects of the event. In the event of unforeseen accidents or illness or circumstances beyond the control concerning the staff of An Affair to Remember, J Byous Photography a substitute will be provided to cover the event.

6. It is understood that other photographers, amateur or professional, shall be allowed to photograph at the wedding while An Affair to Remember, J Byous Photography is working only at the discretion of An Affair to Remember, J Byous Photography, and that any breach of this agreement will constitute a reason for non-completion of the job with no liability to An Affair to Remember, J Byous Photography and loss of deposits by signing party.

All terms of this agreement are understood and agreed upon.

A deposit of twenty-five percent (25%) of estimated total is due upon signing of the contract to retain our non-photographic services are non-refundable and will apply to the percentage which is our fee for the total package. The balance of the fee to An Affair to Remember, J Byous Photography will be needed and due in total two weeks prior to the wedding. Balances due to vendors will require at time set forth in vendor contracts. A cost estimate is made by An Affair to Remember, J Byous Photography at the onset. Any additions, deletions or other changes will be calculated into the final amount. There will be no additions, deletions or other changes made without full knowledge of the bride or of An Affair to Remember, J Byous Photography.
